IMPORTANT INFORMATION

This **Transparency Report** presents the main financial and operational information of the Association LATGA in 2019, the audit conclusion and a special report on the creative and cultural activities of the authors of the Association LATGA.

The **Association LATGA** is a non-profit collective management organization for copyright and related rights having a status of a legal entity whose main purpose is to manage collectively the property rights of the authors and the rights of the holders of related rights and to represent and protect the rights and legitimate interests of the members of the Association. The bodies of the Association are the General Membership Meeting of the Association, the collegial body is the Council, the sole bodies are the Director of the Association and the President of the Association, the Audit Commission performing the functions of supervision, and the non-executive body the Ethics Commission. The governing bodies of the Association are the Council and the Director.

Each member of LATGA resolves the most important issues at the **General Membership Meeting**.

The **Council** elected by the General Membership Meeting resolves relevant current issues, establishes mandatory work tasks. The Council forms and implements the policy of LATGA. Seven members were delegated to the Council from the members of the Creative Union of the Association LATGA; six members of the Council are freely elected. Elections to the LATGA Council took place in 2016.

The **President** of the Association, Teisutis Makačinas, represents the Association, convenes meetings of the Council, presides over them.

The **Ethics Commission** consists of five members of the Association, who were elected at the General Membership Meeting for a term of four years. The Ethics Commission, on its own initiative or at the Council's discretion, considers disputes between the members of the Association, misconduct of members of the Association, and any other violations of the ethics by the members of the Association. The members of the Ethics Commission are Dainius Babonas (songwriter), Erika Drungytė (poet), Vėtrė Antanavičiūtė (designer), Nijolė Vilutienė (artist), Birutė Jonuškaitė (writer).

The **Audit Commission** is the supervisory body ensuring the management of the Association elected by the General Membership Meeting of the members of the Association for a term of four years. The Audit Commission is responsible for monitoring the activities of the Association and its governing bodies. The members of the Audit Commission are Kazys Daugėla (composer), Algimantas Biguzas (artist), Eligija Volodkevičiūtė (prose writer, scriptwriter), Irena Žvinklevičienė (author of music and texts), Alvydas Jegelevičius (composer).

Association LATGA collectively administers the rights of authors, publishers of music works, and AV producers. Collectively administered rights are as follows:

Foreign organizations of collective administration with which representation agreements have been signed during the reporting year

Based on reciprocal representation contracts, the Association LATGA currently represents over 20 million foreign works and over 4 million authors of music and drama, visual arts and audio-visual art works and producers from around the world. Today, LATGA has signed 170 international mutual or unilateral representation agreements with associations of collective copyright administration from 69 foreign countries:

76 contracts (66 countries) - music

38 contracts (34 countries) - visual works

17 contracts (20 countries) - drama

38 contracts (29 countries) - audiovisual works

1 contract (1 country) - for the reproduction of works by reprography

The Association LATGA is a member of the following international copyright societies:

• CISAC - International Confederation of Societies of Authors and Composers. The Confederation was established in 1926 on the initiative of authors' societies from 18 countries. CISAC currently unites 232 associations of collective copyright administration of music, audiovisual works, drama, literature and visual works from 120 countries around the world. Currently, the President of CISAC is Jean-Michel Jarre, the pioneer of electronic music. The LATGA has been a member since 1992.

• EVA - European Visual Artists. Unites 26 members. The EMEA started its activities in 1997 and the organization currently unites 26 members, the European authors' collective management societies for the visual arts, which together represent almost 100,000 authors of fine arts, illustrations, photography, design, architecture and other visual works. The LATGA has been a member since 2000.


• IFFRO - International Federation of Reproduction Rights Organisations that launched its activities in 1980. The International Federation of Reproduction Rights Organizations now has 145 members representing the rights of literary and visual arts authors and rightsholders when their works are reproduced by reprography. The LATGA has been a member since 2003.

• GESAC - European Grouping of Societies of Authors and Composers. GESAC is currently comprised of the associations of collective copyright administration from 33 European countries, representing more than a million creators and rightsholders - musicians, writers, visual artists, filmmakers and many other authors in the fields of music, audiovisual, fine arts and literature and drama works. The LATGA has been a member since 2005.

• BIEM (Bureau International des Sociétés Gérant les Droits d'Enregistrement et de Reproduction Mécanique) – Confederation of Societies Administering the Rights of Mechanical Recording and Reproduction. BIEM unites 53 members from 58 countries around the world and has been operating since 1929. The LATGA has been a member since 2016.

• SAA - Society of Audiovisual Authors. SAA represents the interests of associations of copyright collective administration and their members - audiovisual authors - in Europe. The SAA unites 33 associations from 25 European countries representing more than 140 000 European film and television scriptwriters and directors. The LATGA has been a member since 2018.

DIVISION OF MUSICAL WORKS

Concerts and Events

In 2019, 650 license agreements were concluded for the use of musical works in concerts and events. In 2019, a number of world-renowned performers such as Eros Ramazzotti, Katie Melua, Sting, Placido Domingo, LP, Sarah Brightman, David Garraret, Salvador Sobral, McFerrin, etc. held their performances in Lithuania. In 2019, Lithuanian performers in the big arenas gave a number of concerts: JAZZU, SEL, Kearbedi, Saulius Prūsaitis, Gytis Paškevičius, Daddy Was A Milkman, Marijonas Mikutavičius, etc.

In 2019, the number of festivals remained the same as in previous years, the main ones being "Gaida", "Pažaislio Music Festival, "Kaunas Jazz", "Vilnius Jazz", "Mama Jazz", "Granatos Live", "Bliuzo naktys", "Roko naktys", "Galapagai", "Juodaragis", "Velnio akmuo", "Vilniaus Fejerija", "Karklė Live Music Beach", "M.A.M.A. Summer" and "Midsummer Vilnius".

Background Music

Currently, LATGA employs 4 specialists serving the territories of Vilnius, Kaunas, Šiauliai and Panevėžys. The main functions of the specialists working in the regions were to find new clients and establish contracts with them, as well as to manage contacts with "difficult" clients. In 2019, 117 cases of illegal use of works were recorded. Most part of problems related to illegal use of works was resolved peacefully and without going to courts.

In 2019, LATGA the specialists concluded 1,314 new contracts, in which payments in both percentages and fixed sums were foreseen for the use of the works, with fixed amounts being paid monthly.

Reproduction of Works

In 2019, 164 applications for publishing albums or their additional releases were received, and 42 completely new contracts were signed with users of works on the right to reproduce the repertoire of LATGA in a media storage device.

THE ARTS DEPARTMENT

There are four subdivisions in the Arts Department: Audiovisual Arts, Drama works, Reprographic Reproduction and Usage of Books and Visual Arts; they are engaged in the administration of the rights of authors and producers of audiovisual works, authors of drama works and visual arts; distribution of compensatory remuneration for the reproduction of works for personal purposes in analogue and digital media storage devices, compensatory remuneration for the right to resell works of art, for the use of books in libraries and for reproduction by reprography.

In 2019, the author's or compensatory remuneration was distributed to almost 2,900 Lithuanian authors - directors, screenwriters, cinematographers, writers, book translators, artists, photographers, designers, playwrights, scenographers, choreographers, theatre composers and other artists.

PROJECTS

In 2019, the Association LATGA completed the implementation of two projects after receiving partial funding from the Culture Council under the Copyright and Related Rights Protection Programme.

April 2019 - June 2019

WIPO DAY IN SCHOOLS

Last year, a series of educational events organized by the Association LATGA dedicated to the World Intellectual Property Day (WIPO) took place for the third time. Fifteen well-known authors from various fields have returned to their former schools to encourage young people to create, tell about the damage of piracy, and also provide knowledge about legitimate ways to use intellectual property.

The World Intellectual Property Day (WIPO) is celebrated on April 26, but this year, the project "WIPO Day in Schools" implemented for the third year in a row and co-financed by the Lithuanian Culture Council under the Copyright and Related Rights Protection Programme lasted until the end of the school year. Like last year, this year fifteen lessons were organized in various schools of the country, which were led by well-known authors from various fields in schools in Vilnius, Kaunas, Panevėžys, Radviliškis, Šiauliai, Alytus and other cities. This year, singers and music authors Vaidotas Valiukevičius, Kazimieras Likša, Miglė Vilčiauskaitė-Migloko, Markas



Palubenka, a former member of the legendary group "Foje" Arnoldas Lukošius, who is now participating in the activities of the group "Other Rooms", joined the project.

The film authors were represented in the project by directors Donatas Ulvydas and Ramunė Rakauskaitė and film operators Kristina Sereikaitė and Eitvydas Doškus. The artist Algirdas Gataveckas "worked off" as a teacher for himself and for his brother Remigijus, who suddenly became ill, in two schools in Alytus. Lina Žutautė, a writer, illustrator, author of the book series about Kakė Makė, playwrights Herkus Kunčius and Aleksandras Špilevoj and children's writer Gintarė Adomaitytė also took part in the project. The discussions were moderated by the specialists of the Association LATGA.

"All the authors involved in the project, without exception, had something to tell from their experiences of some form of copyright infringement, not necessarily related to Internet piracy, and the children listened intently to them. Of course, the biggest victims of piracy are those authors, e.g. filmmakers, music authors, writers, whose works can be uploaded to the Internet in one form or another. You do not need to do complicated research to understand the extent of such thefts, you just have to enter the names of authors or works in an Internet search and you will get a bunch of links to sites where you get the desired music album,

movie or book in PDF format after paying for a "VIP invitation" or "monthly subscription". In preparation for the project events, we realized that nothing is sacred to pirates - even very specific documentaries by Lithuanian

authors and abundantly illustrated children's books are uploaded to the Internet. Therefore, when countrymen say that they are not interested in Lithuanian creative work, they really tell fairy tales - after all, if there was no demand, there would be no supply. On the other hand, we do not divide the authors into Lithuanian and foreigners, because we represent many creators of the world on the basis of international agreements," stated Jurgita Kviliūnaitė, the author of the project idea and public relations specialist of the Association LATGA.

Film director D. Ulvydas also spoke about the relationship between demand and supply, during the project "WIPO Day in School", he was briefly returned to his former school - Šiauliai Ragainė Progymnasium. "It is very difficult to catch Internet hackers like ordinary pirates. They have a very good knowledge of information technology, know how to go into hiding, so you need to look for other ways as well.

One of them education. is Unfortunately, the film industry does not have its own "Spotify" yet, where the films from all over the world can be found, so I can only ask you not to use pirated websites but search for your favourite film on legal platforms and to encourage your parents to behave the same way. The lower the demand is, the lower the supply will be. In other words, pirated websites will close on their own if no one visits them and will not raise capital to their administrators," the director explained enthusiastically after receiving a record number of student questions and staying at the school several times longer than planned.

R. Rakauskaitė, a documentary filmmaker who comes from Alytus, also urged students from her hometown not to download films from pirated websites, offered to watch them in cinemas or at least on legal platforms, and emphasized quality. "People lose a lot by watching copies of poor-quality films on a small computer screen. After all, from the beginning, the films were designed to be viewed on the big screen. And when it comes to the dark side of piracy, it is all very simple: if filmmakers do not make money from film reviews in cinemas or the Internet, they just will not be able to continue creating them sterlingly and with dignity", she said.

The writer and illustrator L. Žutautė also spoke about quality differences. "I have encountered various violations of rights more than once, but I learned from the Association LATGA about the fact that the books I created are being placed on pirated websites in PDF format. I couldn't believe it, because illustrations are very important in my books, and they do not look good on a computer screen or reprinted", said the author of the books about Kakė Makė.

All the songwriters who participated in the project were glad that the situation in the field of music changed significantly when "Spotify" and "Deezer" came to Lithuania, and the Lithuanian platform "Pakrtot.It" was established. However, this also did not seem to become a complete panacea - a number of students admitted that they still download music from pirated websites because "you don't have to pay and you can listen without the Internet". Also, there is no need to listen to commercials that pop up while listening to music on legal free platforms.

A. Lukošius, who has written about information technologies for some time and now advertises them, probably most accurately explained what Internet piracy is. "If in the past it was like a kind of cover to say that this is a kind of fraternal sharing, not for profit, now it is the same business, only of criminals. Where have you seen a pirated website that would take everything and share without advertising, fees, the requirement to disable "AdBlocker"? Probably not. <...> "Yes, perhaps it could be said that pirates once forced to create more democratic business models, but now when we have both legal and low-cost ways to use the work of creators, piracy really makes the world worse", he said.

His opinion was also supported by another project participant, music author Vaidotas Valiukevičius. "I am involved in this project because I want to encourage young people to use legal platforms to find their favourite music or film. Why? Because piracy is the same theft as others. The less we steal from each other, the healthier the whole society will be and the more prosperous. Moreover, we are still pirating because too little is talked about it. Of course, there are still old habits from times when it was difficult to find legal sources on the Internet. However, there are already a lot of platforms, websites where all the content is legal."

"In 2017, when we started the project, we realized that it was not enough to say "do not steal" without explaining the context. Thus, from the very beginning, we not only learned to distinguish between legal and illegal websites but also talked about how

on both the Lithuanian and global cultural and artistic sectors. We also tried to explain to the children who the author is, what rights he has, why the author needs collective administration of rights, etc. We believe that in the future, such lessons will become part of the curricula of educational institutions and many young people will acquire the basics of copyright. Even if they do not follow in the footsteps of project participants and become authors, they may at least respect those who create. Education is a very complicated way, but if it is not implemented, the situation will not change substantially", said the project manager J. Kviliūnaitė.

VIDEO CONFERENCES-DISCUSSIONS ON COPYRIGHT

When preparing the project "Video Conferences-Discussions on Copyright" funded by the Lithuanian Culture Council under the Copyright and Related Rights Protection Programme, together with our partner - the portal 15min.lt - we sought to fill knowledge gaps about the copyright system with the help of both specialists of Association LATGA and from other organizations working in the field of copyright, as well as we invited well-known authors from various fields to the discussions. From April to December 2019, seven video conferences-discussions were held live on the portal 15min.lt.



Our society catastrophically lacks knowledge about the legal uses of works, legal access to works, compensatory remuneration for the use of works for personal purposes, etc. It is obvious that analytical and educational articles, radio and television programs, video clips, and other media, which promote the legal use of works foster respect for intellectual property and condemn the illegal use of works, are much needed. The aim of the project is to acquaint the public with the activities of collective

management of copyright and anti-piracy organizations, amendments to the Law on Lithuanian Copyright and Related Rights, to inform about current issues of copyright and related rights protection in Lithuania and the world, latest research, anti-piracy websites in Lithuania and the world, legal platforms for the use of works in various fields of art on the Internet accessible in Lithuania and to answer other questions of public interest about the protection of copyright and related rights.

The following topics were discussed during the project, together with the well-known authors and specialists of the Association LATGA:

- The main problems and challenges faced by Lithuanian authors, what measures are taken to protect them both in Lithuania and in Europe; European Union Copyright Directive in the Digital Single Market, its implementation in Lithuania. Reviews: 15min.lt: 2.3 thousand, 15min.lt Facebook and Youtube accounts: 5.7 thousand. The total number of reviews - 8 thousand. Laura Baškevičienė, Deputy Director of the Association LATGA, and Vaidotas Valiukevičius, a member of the group "The Roop", a participant of the project "WIPO Day in Schools", visited 15min.lt.
- On the occasion of the 29th birthday of the Association LATGA, the most important facts of the history of this organization were remembered, the main aspects of the activity were discussed and an attempt was made to find out how much almost 5,000 Lithuanian authors earned from the use of works per year. Reviews: 15min.lt: 3 thousand, 15min.lt Facebook and Youtube accounts: 6.1 thousand. The total number of reviews 9.1 thousand. Laura Baškevičienė, Deputy Director of the Association LATGA, a poet, translator and the LATGA Council member Vladas Braziūnas and music author and producer Leonas Somovas visited the 15min.lt studio.
- The top ten of the most read books in libraries were announced and the consideration was given to how authors were paid compensatory remuneration for the use of books in libraries. Reviews: 15min.lt: 22.2 thousand, 15min.lt Facebook and Youtube accounts: 3.6 thousand. The total number of reviews
 25.8 thousand. Popular writers Lavija Šurnaitė and Gina Viliūnė and the head of the Association LATGA, a writer and poet Jonas Liniauskas visited the 15min.lt studio.
- What kind of copyright violations do authors in the field of art face? Reviews: 15min.lt: 13.7 thousand, 15min.lt Facebook and Youtube accounts: 3.3 thousand. The total number of reviews - 17 thousand. Ingrida Kruopštaitė, the head of the Arts Department of the Association LATGA, and artists Arūnas Rutkus and Arūnas Žilys visited the 15min.lt studio.
- Problems of music copyright in Lithuania and in the world; for what and how royalties are collected for music authors. Reviews: 15min.lt: 5.1 thousand, 15min.lt Facebook and Youtube accounts: 8.1 thousand. The total number of reviews - 13.2 thousand. Paulius Sartatavičius, the head of the Music Works Department, and two well-known music authors - a composer Vytautas Bikus and member of the "G&G Sindikatas" Kastytis Sarnickas-Kastetas, who won several awards at this year's M.A.M.A. visited the 15min.lt studio.
- Is it possible to live from the cinema in Lithuania? Who earns the most in cinema: producers, authors, or pirates? Reviews: 15min.lt: 3.2 thousand, 15min.lt Facebook and Youtube accounts: 20 thousand The total number of reviews 23.2 thousand. Vilma Juraškienė, the head of the Audiovisual Arts Subdivision of the LATGA, and well-known film directors Arūnas Matelis and Giedrė Beinoriūtė visited the 15min.lt studio.
- What is the key to success for groups and performers: good songs or hard-working manager? What
 encourages and what demotivates the Lithuanian music authors to create songs? Does Lithuanian music
